Lutheran Historical Society of the Mid-Atlantic Annual Meeting, April 9, 2019 Dining Hall, Gettysburg College Campus

The annual meeting of the Lutheran Historical Society of the Mid-Atlantic was held on April 9, 2019, in the Dining Hall on the Gettysburg College campus. President Steve Herr called the meeting to order at 6:10 PM and welcomed the membership. Herr noted this was the first time the society has hosted an evening banquet and lecture program.

President Herr determined that a quorum for the meeting existed.

A motion to accept the meeting agenda as submitted was made by Lee Knepp, seconded by Maria Erling. **Approved**.

The minutes from the April 17, 2018, annual meeting were **approved** on motion of Kevin Hepler, seconded by Mark Oldenburg.

Officers Reports:

- a. President's Report: President Herr thanked all members for their attendance, as well as current board members for their service. He also thanked former board member Marianne Brock and retiring board members Jill Ogline Titus and Jane English for their service.
- b. Vice-President's Report: No report.
- c. Secretary's Report: No report.
- d. Archivist/Historian's Report: No report.
- e. Treasurer's Report: Treasurer Lee Knepp submitted a written report on the Society's finances from January 1 to April 4, 2019, as well as a report from January 1 to December 31, 2018, for comparison. Balances remain stable. The treasurer's report was **approved** on motion of Jon Peterson, seconded by Mark Oldenburg.

Award Updates: President Herr recognized Pastor Benjamin Phelps, winner of the 2018 Wentz Prize, who was in attendance. Entries for the 2019 Wentz Prize are due on August 31, 2019. The St. Paul/Biglerville Prize is due to be awarded again in 2020.

New Business:

a. Vice President Mark Oldenburg reported for the Nominating Committee. The committee presented the following names to fill five open seats on the board for a 3-year term, including Beth Clementson, Maria Erling, John Fehringer, Louise Meledin, and Sean Titus. Standing to fill two

The A.R. Wentz and St. Paul, Biglerville prizes promote scholarship con-

cerning Lutheranism in America. The historic site recognition program seeks to raise awareness of places that have significance in Mid -Atlantic Lutheranism, while also encouraging congregations to develop their own preservation and sharing of their history. In order to help congregations throughout the region develop their archives and the telling of their history, a congregational heritage workshop is being planned for next spring. Our annual meeting in April focused on Henry Gereke and his chaplaincy to the Nazi war criminals tried at Nuremburg for crimes against humanity. The lecture was a look back at the ministry of a Lutheran Church-Missouri Synod pastor and United States Army chaplain in the aftermath of World War II. Keynote Tim Townsend told the historical story of Gereke, however, he also succeeded in inviting participants to reflect deeply on themes

> of human sinfulness, war and peace, as well as justice and mercy. His exploration of Gereke was not only a story of the past, but also of the present. It spoke of the value of military chaplaincy and the challenge to min-

ister to those who have done great harm to other human beings. It invited us all to see how one man's actions help us reflect on our own time, actions, ethics, and moral action.

The 2018 Abdel Ross Wentz prize winner Pastor Benjamin Phelps from Kenai, Alaska spoke briefly about his winning paper concerning the confessionalism of Friedrich C.D. Wyneken. Wyneken became the second president of the Lutheran Church-Missouri Synod. Phelps reminded readers of Wyneken's commitment to Lutheran confessionalism amidst a pan-Protestant religious environment on the American frontier. Phelp's study reminded readers of the importance of the Lutheran confessions and their continuing importance and place in the church today. I found the Wyneken study reinforced the importance of the Lutheran confessions and their applicability in our time as they were for Wyneken in his.

Thank you to all who attended our annual meeting, evening banquet and lecture. We had a great turnout for the banquet and meeting with close to one hundred in attendance for the Townsend presentation. Featured Lutheran: Elsie Singmaster Lewars

Elsie Singmaster (Lewars) was an O. Henry and Newberry award winning author of short stories and books during the first half of the twentieth century. Singmaster is well known for her stories about the Pennsylvania Germans from whom she descended on her father's side. A resident of Gettysburg from 1900-1958, she also wrote widely about the Battle of Gettysburg. In 1907, she was graduated from Radcliffe College, Cambridge, Massachusetts. Singmaster was a lifelong Lutheran. She worshipped at Christ Evangelical Lutheran Church in Gettysburg and served broadly in church and community leadership capacities. She wrote *Martin Luther, The Story of His Life* in 1917 to help celebrate the Lutheran-sponsored Quadra-centennial of the Reformation. Singmaster was the daughter of John Alden Singmaster, professor and president at the Lutheran Theological Seminary at Gettysburg from 1900 until his death in 1926.

LHSMA Board Happenings

The board of the Lutheran Historical Society of the Mid-Atlantic met on May 22, 2019. President Steve Herr called the meeting to order at 10:32 AM at Valentine Hall, United Lutheran Seminary (Gettysburg Campus). President Herr

welcomed board members to the meeting and led introductions around the table as well opening devotions and as shared some historical background about the society for the benefit of newly elected members.

The minutes of the January 24, 2019 board meeting were distributed and a motion to approve was made by David Flesner, seconded by John Fehringer. Approved.

President Herr proceeded to facilitate the board reorganization for 2019. Vice President Mark Oldenburg reported for the Nominating Committee that the current incumbents - including Steve Herr, President; Mark Oldenburg, Vice President; John Deeben, Secretary; Lee Knepp, Treasurer; and Sheila Joy, Archivist/Historian are willing to stand for reelection. There were no additional nominations from the floor. John Fehringer made a motion to close nominations and approve the slate of nominees, seconded by Sean Titus. Approved. President Herr then determined assignments for each standing committee, including Publicity, Membership, Program, and Historic Site Recognition.

Officers' reports followed. President Herr thanked everyone for their willingness to serve on the board. Herr noted the society continues to have a role to play in the wider society as a whole. Herr also thanked everyone who helped plan or otherwise participated in the Spring program. Thirty-seven people attended the society dinner, and over 100 attended the lecture by Tim Townsend.

Secretary John Deeben sent around the updated board list for additions and corrections to contact information. The Summer newsletter deadline was set as July 1.


> Archivist/Historian Sheila Joy reported two recent acquisi-

- Membership: Jim Mummert reported an idea to correspond with pastors to send potential names of members who might be interested in Lutheran history. It will probably take a year to develop this particular recruitment idea. We also need new stationery and envelopes for the society. A printed report on membership numbers was distributed to the board, showing 40 life members, 82 annual, and 10 institutions.
- Publicity: Mark Oldenburg reported two display boards are going out to upcoming synod assemblies. Work is still progressing on a new logo design. Beth Clementson volunteered to be the board's social media guru. Some interest in the society came back from the targeted invitations that were sent out for the Spring program.
- **Program**: Steve Herr reported that the banquet format for the annual meeting/Spring program was successful but not sure if it can be replicated if the program topic is not broad enough. The Lutheran Historical Con-


Member Biographies:

Andrew Frantz

A lifelong Lutheran and native of the Lehigh Valley, Andrew Frantz currently lives in Gettysburg where he is a seasonal park ranger at Gettysburg National Military Park. He holds history degrees from the College of William & Mary and the University of California and has previously worked at a number of historic sites and museums across the country, including the Yorktown battlefield, Colonial Williamsburg, Old Salem Fort McHenry, and Hampton National Historic Site. He primarily studies the military, political, and religious history of the British empire in the seventeenth and eight-eenth century (especially in North America) as well as the world wars. He and his wife, Rebecca (the pastor at St. John's, Littlestown), are expecting their first child in October.

Sean Titus

The Rev. Sean Titus serves as pastor of Trinity Lutheran Church in Jefferson (Codorus, Pennsylvania). In addition to holding a M.Div. from the Lutheran Theological Seminary at Gettysburg (now United Lutheran Seminary), he also holds a M.A. in history from the University at Buffalo. He formerly taught history and geography at Chincoteague High School in Chincoteague, Virginia. He is a native of western New York State, and is the husband of former board member, Jill Titus.

ference will be coming next fall to the Baltimore or Gettysburg area; details are still evolving. The committee wonders if the annual program should be tied to the LHC fall event, and we do something more local in the spring. The possibility was also raised to do a Congregational Heritage Workshop in conjunction with the annual meeting in the spring.

• **Historic Site Recognition**: Sheila Joy noted that plaques are needed for Linwood House and Salem Lutheran Church, Lebanon. Ap-

plications are now being accepted for new sites to recognize.

• Nominating: The committee will reorganize with Mark Oldenburg and John Deeben, with John Fehringer serving as a consultant.

There was no Old Business. Under New Business, some goals were identified for next meeting, including a resolution of remaining details for the next annual meeting. The society's bylaws and constitution have not been reviewed since 2002; standing rules since 2014. An adhoc group may be appointed to review those documents at a later date.

The board meeting adjourned at 12:55 PM with recitation of the Apostle's Creed.


