# Lutheran Historical Society of the Mid-Atlantic

### Annual Meeting & Fall Program Recap, Nov. 30, 2021

The Lutheran Historical Society of the Mid-Atlantic met virtually via Zoom for its 2021 annual meeting and Fall program on Tuesday, November 30, 2021. President Steve Herr called the annual meeting to order at 7:02 PM and welcomed the membership.

The annual meeting minutes from the October 22, 2020, were reviewed by Secretary John Deeben, and then **approved** on motion of Jon Diefenthaler, seconded by Kevin Hepler.

Treasurer Lee Knepp reported the current balances of the society's accounts, and noted that all bills have been paid to date. Expenses have been down but the balance has increased slightly. A motion to accept the Treasurer's Report was made by David Flesner, seconded by Kevin Hepler. Approved.

Jon Diefenthaler reported that the 2021 St. Paul/Biglerville Prize was awarded to Matthew E. Borrasso for his book, *The Art of Exegesis: An Analysis of the Life and Work of Martin Hans Franzmann*. Matt was present for the virtual meeting and expressed his gratitude and provided a little bit of background about himself.

Under New Business, Vice President Mark Oldenburg reported for the Nominating Committee. The committee

recommended Kevin Hepler, Victoria Jesswein, Stephen Herr, Mark Oldenburg, and Paul Tomkiel to fill open 3-year terms. Mark opened the floor for further nominations. There being none, the committee asked for the society membership to approve these board appointments, on motion of Lee Knepp, seconded by Kristi Keller. **Approved**. President Herr thanked outgoing board member David Flesner for his service, and welcomed newcomer Victoria Jesswein to the board.

The annual meeting adjourned at 7:15 PM on motion of Jon Diefenthaler, seconded by Hepler. Approved. The online event then moved into the Fall Program portion of the evening, which featured presentations by the 2019 and 2020 A. R. Wentz Prize winners. The Reverend Joel Otto received the 2019 prize for his paper "The Church Grows under the Cross: WELS Mission Expansion, 1929-1983." Otto is a professor of church history and education as well as the Dean of Students at Wisconsin Lutheran Seminary in Mequon, Wisconsin. He explained that the main premise of his paper centered on how the Wisconsin Synod was able to do quite a bit of challenging mission work under difficult circumstances.

## Meet New Board Member Victoria Jesswein

United Lutheran Seminary archivist Victoria Jesswein was elected to the board of the Lutheran Historical Society of the Mid-Atlantic during the society's annual meeting on November 30, 2021. At the board's follow-up reorganization meeting, Victo-



ria was appointed to serve as the society's archivist/ historian. Regarding her election and appointment, Victoria noted, "I'm looking forward to getting involved with the Historical Society and serving on the Board as Archivist. Originally from East Texas, I moved to Gettysburg in

May 2021, when I started in my current position as Archivist at United Lutheran Seminary. I grew up Lutheran (LCMS), and I received my Master's in Archives and Records Management from the University of Liverpool. I'm excited to learn about, share, and preserve Lutheran history in the Mid-Atlantic region!"

Victoria received a B.A. with Honors in Linguistics and German Studies in 2018 from the University of Texas at Austin. She also holds a Certificate of Continuing Education in Medieval Studies from the University of Cambridge. Victoria has extensive

experience with libraries and archives including reference services, preparing programs and exhibitions, appraisal, arrangement and description of material, digitization, paleography, and codicology. She also has a special interest in endangered culture and language libraries/archives, LGBTQ+ studies, rare books, and special collections, as well as experience with tutoring and teaching. Prior to coming to United Lutheran Seminary, Victoria served as a reference librarian at Sam Houston State University, Paleography Librarian and Department Ambassador at the University of Liverpool, and was an archive intern at Lincoln College, University of Oxford.

At ULS, Victoria manages, processes, and provides access to the ELCA Region 8 Archives and the United Lutheran Seminary Archives including answering reference questions, appraising, arranging, describing, and preserving archival records, researching and reviewing archival donations and records transfers for historical value, building and maintaining the archival database, and compiling statistics and reports. She also trains and manages student workers and participates in professional development and continuing education. The LHSMA archives, housed at the A. R. Wentz Library on United Lutheran Seminary's Gettysburg campus, will be in good hands for the foreseeable future!

## Samuel Whitaker Pennypacker

Samuel Whitaker Pennypacker was born April 9, 1843, in Phoenixville, Chester County, Pennsylvania. As a student during the Civil War, he served in Company F, 26th Pennsylvania Emergency Militia during the Gettysburg campaign, fighting in a brief skirmish north of Gettysburg on June 26, 1863. Pennypacker returned to studying law at the University of Pennsylvania, graduating in 1866. The following year he became president of the Law Academy of Philadelphia.

Pennypacker's public service began in 1885 with his appointment to the Philadelphia Board of Education. He was then admitted to the bar of the Supreme Court of the United States in 1887. Two years later he

#### Faith in the Time of Covid:

### Is Your Church History of the Pandemic Being Preserved?

The COVID-19 pandemic has certainly put a strain on all aspects of life over the past year and a half. Congregations of all denominations have been forced to "pivot" into new and unfamiliar ways of conducting business virtually while trying to stay solvent, remain relevant, and care for the needs of their members from a distance. The results have often been surprising and innovative and should be documented for posterity. Here are a few thoughts on how the resulting experiences of the pandemic can be preserved.

Congregations have Council minutes, birth and death records and financial records because that is required. But that can be enriched by photos or written memories of what church life was actually like during the pandemic.

There were Zoom meetings, Bible studies and even Zoom music performances, but did anyone take a screen shot of that or save it to a thumb drive or the cloud? Communion was not administered for months and then there were communion "pods". Is there a photo of a communion pod for your archives? Is there a written memory of the distribution procedures that were new? How were Christmas and Easter services different?

The deaths were recorded as a number, but is it recorded that there were no funerals? How did the

pastor manage hospital visitations? Is there a photo of a gowned and masked pastor? (That could be recreated for the archives.)

Was there a photo taken of outside worship or

indoor worship with distancing? Was a copy of the sign



-in sheet for contact tracing kept or other written directions for the congregation?

Has a written memory been made of the electronics nightmare of creating a church service for those at home? The federal grant will be mentioned in the Council minutes, but there may be more to that story that could be recorded.

Was the church active in creating cloth masks for the hospitals? A written memory or pattern of the mask and ministry could go in the archives.

The memory of the pandemic and empty shelves at the grocery store is already fading. Please act now to archive this COVID-19 pandemic and how God was at work in your church and community.

began serving a judgeship on the Court of Common Pleas of Philadelphia, becoming president judge in 1897. In 1900 he became president of the Historical Society of Pennsylvania. In 1902 Pennsylvania, serving from January 20, 1903 to January 15, 1907. During his term, the Child Labor Act of 1905 was approved, which set a minimum age and work standards for young factory and mine workers. He also established the Pennsylvania State Police, the first statewide police force in America.

After retiring from politics, Pennypacker opened a law office in Philadelphia. He died on September 2, 1916 at his home in Schwenksville, Montgomery County.

Flesner, seconded by Kevin Hepler. Approved.



Program—Kevin Hepler reported no action items. Maria Erling will meet with the Lutheran Historical Conference planning committee on June 1. The society will tentatively plan for a Saturday October 2 joint session, which will include a brief annual

meeting and possibly the presentation of the Wentz Prize. A call for papers for the LHC sessions can be included in the summer newsletter.

#### Officers' Reports:

President Steve Herr reviewed recent society activity, including the awarding of the Wentz Prize at the end of 2020.

**Secretary** John Deeben set July 9 as the submission deadline for the summer issue of the newsletter.

Treasurer Lee Knepp shared a report covering society finances to date, as well as a copy of the 2020 report for comparison, and a copy of the annual Form 999-N filing with the IRS. Reimbursements for two readers for the Wentz prize have been received so far. There is no update on valuations for the prize funds. A motion to receive the report was made by Kevin Hepler, seconded by Maria Erling. **Approved**.

Archivist/Historian Maria Erling reported that there is now an assistant archivist working at the seminary, Victoria Jesswein. She is based on the Gettysburg campus and is proficient at reading old German handwriting!

#### **Committee Reports:**

Board members broke into brief committee meetings at 5:16 and reconvened at 5:34. The following committee reports were then presented:

Membership—Committee chair John Deeben reported updated membership figures, including 106 annual members, 48 Life members, and 15 institutional members (four of which are Life members). To date, 25 annual members have paid their dues for 2021. Another renewal reminder will be printed in the summer newsletter, and there will also likely be a separate

- Historic Site Recognition—Paul Tomkiel reported that the committee is looking at St. Paul's Lutheran Church in Dansville, NY, which sponsored the first chapter of the American Red Cross. Maria Erling will review the society's archives for old applications. The committee will take another look at the application procedures, with the view of changing it from a competitive award to a straight "apply and receive" process.
- Wentz Prize—Steve Herr reported that given the pandemic and resulting limited access to archives, the deadline will be extended to September 30 this year.
- Biglerville Prize—Sean Titus reported that the prize is on track to be awarded this fall. The panel will meet on August 17 to discuss and review the nominees, and will have a recommendation ready for the next board meeting.

There was no Old Business.

#### **New Business:**

President Steve Herr offered two items for the board's future consideration:

- 1) a suggestion to invite the last two Wentz prize winners to do an online program for the society, and
- 2) a strategic question: what should be our long-term financial goals regarding standing account balances?

The board meeting adjourned at 5:58 on motion by Kevin Hepler, seconded by Jon Diefenthaler. **Approved**.




# LHSMA Awards Biglerville Prize to Matthew Borrasso

The Lutheran Historical Society of the Mid-Atlantic announces that the Reverend Matthew Borrasso is the winner of this year's awarding of the St. Paul, Biglerville Prize in American Lutheran History. Barrosso has written a book entitled *The Art of Exegesis: The Life and work of Martin Hans* 

Franzmann (WIPF & Stock, 2019), which explores Franzmann's contributions to biblical hermeneutics as these developed, and became a focal point of controversy, within the context of both the Wisconsin Evangelical Lutheran Synod the Lutheran Church-Missouri Synod from the late 1920s through the mid-1970s.

The Biglerville Prize is awarded every two to three years by the Society to recently published works of mature scholarship in the field of the history of Lutheranism and Lutheran churches in America. The award includes a sum of \$3000, and the winner is invited to offer a presentation to the Society of their work. The prize was established by St. Paul Lutheran Church in Biglerville, Pennsylvania in honor of the Reverend Frederick Weiser.





This year's winning work, *The Art of Exegesis: The Life and work of Martin Hans Franzmann* is important not just because it provides a biography of the life of Franzmann, who is perhaps better known among Lutherans for the hymns he authored and his poetic expositions of Scripture, but also because it places Franzmann's career in the context of larger trends in twentieth-century American Lutheranism, particularly in regards to how the topic of biblical inerrancy as it was approached within the church and its seminaries. The Society awards the Biglerville Prize to Borrasso for his fine scholarship and his dedication to the study of Lutheran history.

### Managing Church Records, Part II:

### Legal and Vital Records

The following information on how to manage church records is based on guidelines© developed by the ELCA's Office of the Secretary. More information is available on the ELCA website at <a href="https://www.elca.org">www.elca.org</a>.

Congregations typically create and retain records that are vital to its daily operation and activities, legal protection, and financial security, all of which contribute to its eventual historical record. For the well-being of the congregation, each type of record has a specific lifecycle and needs appropriate care. The second part of this overview looks at Legal and Vital Records.

Legal and Vital records cover important aspects of the life of the congregation. They include documents pertaining to the establishment of the congregation, such as:

- 1) the Charter and Articles of Incorporation; and
- 2) the Constitution, bylaws, and continuing resolutions.

There are important records that relate to the physical property of the congregation, including:

- 3) deeds, titles, surveys, leases, mortgages, and easements;
- 4) blueprints and construction drawings;
- 5) insurance policies (both current and retired); and
- 6) current service or construction contracts and warranties.

Important personnel-related documents include:

- 7) copies of Letters of Call to the pastors and ELCA rostered church workers;
- 8) employment contracts; and
- 9) personnel handbooks and employee benefit programs.

Other important records of a legal or vital nature include:

10) documentation creating endowment funds

and for bequests, gifts, and endowments;

- 11) minutes of regular and special congregational meetings;
- 12) minutes of the congregation council and its executive committee;
- 13) policy documents (which may be in continuing resolutions; and
- 14) tax-exempt status reports and documentation or the congregation's nine-digit federal employer identification number.

All of these records, of course, should be maintained while they are current. The legal and property records should be secured in a fire-proof safe or by maintaining copies in an off-site location. The constitution should be kept current, and any revisions sent to the synod for approval. All of these records are permanent and should eventually be placed in the congregation's archives. For certain legal records of a current nature, such as the constitution, it would be appropriate to retain reference copies in the archives while the originals are kept in secured storage.


